TERMS & CONDITIONS

1. Tender Bidding documents/ Bill of Quantity (BOQ) can be downloaded **One Day Before** from PDA website, www.pda.gkp.pk.
2. 2% (two percent) earnest money/bid security must be accompanied in shape of Call Deposit or Pay Order in name of the Director General, Peshawar Development Authority Peshawar, from schedule banks in accordance with the Rule 20(2) of KAPPRA Rules 2014 and subsequent amendments (if any).
3. Only up to two decimal digits (0.00) will be considered for evaluation of the quoted bid. If any document submitted along with bid documents found false / bogus the registration of the contractor / firm shall stands cancelled / blacklisted. Conditional / incomplete bids shall not be acceptable.
4. All the bid received through courier service / by hand.
5. Tender shall be opened in the office of the undersigned.
6. In case bid becomes tie, it shall be retendered.
7. All the Government taxes (Federal, Provincial & any other) will be deducted as per prevailing Government policy.
8. Incomplete / disfiguring / overwriting / delayed bids shall be considered non-responsive.

9. The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals. The procuring entity shall upon request communicate to any contractor who submitted a bid or proposal the grounds for rejection or of all bids or proposals as per KPPRA 47(1).
10. Other terms & conditions pertaining to the work can be seen in the office of the undersigned at any working day during office hours.
11. Validity of bid will be 90-days from date of opening of the tender.
12. The contractors / bidders who quote their bids / rates more than 10% below the Engineer's estimate shall submit an Additional Security in the form of call deposit equal to 8% of the estimated cost. After commencement of work by the successful bidder 8% call deposit should be replaced with a bank guarantee of the same amount from the scheduled bank in accordance with the notification KPPRA/M&E/Estt:/1-5/2016, Dated 24/05/2016, as amended on June 06/2017.
13. Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS- (on which PC-I is approved) with the approval of the competent authority.
