TERMS & CONDITION

1. Tender documents/BOQ can be downloaded up to one day before opening of Tenders from PDA web site, at www.pda.pkp.pk. Interested contractors/firms are requested to obtain user name and password from P&D Section of PDA to download, tender forms and BOQs.
2. 2% (two percent) earnest money must be accompanied with the tender documents in the shape of call deposit or Pay Order in the name of Director General PDA from scheduled Banks branch at Peshawar. Copies of the requisite documents like enlistment/renewal, Income Tax Certificate and PEC Registrations, NTN etc must be attached with the tender documents, while original be produced to the Tender Opening Committee at the time of opening for confirmation.
3. The tender form /documents fee to be submitted separately and shape of call deposit /pay order in the name of Director General, PDA.
4. Incomplete /disfiguring/overwriting/by hand/delayed bids shall be considered non-responsive
5. All federal and provincial duties/stamp duty/taxes including sales tax will be recoverable as per directives of the government issued from time to time.
6. In case the bid becomes tie, the work will be retendered.
7. Rates must be written both in figures and words. The contractors will sign all the pages of BOQ in case of Non compliance tender shall not be entertained for competition.

8. Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2017/prevailing market rates with the approval of the competent authority.
9. The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals. The procuring entity shall upon request communicate to any contractor who submitted a bid or proposal the grounds for rejection of all bids or proposals as per KPPRA 47(1).
10. The contractors/bidders who quoted their bids/rates more than 10% below the Engineer's Estimate shall submit an Additional Security in the form of call deposit equal to 8% of the bid cost. After commencement of work by the successful bidder 8% call deposit should replace with a bank guarantee of the same amount from the schedule bank in accordance with the notification KPPRA/M&E/Estt./1-5/2016 dated 24/05/2016.
11. Other terms and conditions can be seen in the office of the undersigned on any working day during office hours.
12. Tender received via registered courier will be entertained only.
