3. 2% (two percent) earnest money must be accompanied with the financial proposal in the shape of call deposit in the name of Director General PESHAWAR DEVELOPMENT AUTHORITY from scheduled Bank. Copies of the requisite documents like renewal, Income Tax certificate, etc. must be accompanying the Bid.
4. The tender Document fee as mentioned above shall be payable through demand draft or pay order in the name of Director General Peshawar Development Authority Peshawar (non-refundable).
5. The tender documents must be signed by an authorized person of the firm/company.
6. The bidders quoting more than 10% below engineer's estimate shall submit additional security in form of call deposit equal to 8% of the estimated cost. After commencement of work by successful bidder 8 % call deposit should be replaced with a bank guarantee of the same amount from the scheduled bank in accordance with the notification KPPRA/M&E/Estt/1-5/2016 dated 24-05-2016, as amended on June 06, 2017.
7. Sealed bids shall be sent through registered mail/Courier service, which must reach in the office of the undersigned before closing time and date mentioned above.
8. The bid documents received through fax will not be acceptable.
9. In case bids become tie among the lowest, it shall be re-tendered.
10. The bidders are at liberty to seek any clarification or further information from the office of the undersigned if desired.
11. All federal and provincial duties /stamp duty /taxes including sales tax will be recoverable as per directives of the government issued from time to time.
12. Any disfiguring /over writing, manipulation in the tender shall be liable to rejection.
13. Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
14. Incomplete/conditional bid shall not be acceptable. Furthermore the authority may reject any or all bids at any time prior to the acceptance of bid or proposal with a cogent reason under rule 47 of KPPRA rules 2014.
15. The bidder shall submit documentary proof of active Tax Payer status showing Last Five years all Taxes.
