2. 2% (two percent) earnest money/bid security must be accompanied in shape of call Deposit in the name of Director General, Peshawar Development Authority Peshawar, from scheduled Bank. Copies of the requisite documents like renewal, income Tax must be attached with the tender documents in a separate envelop.
3. The tender documents fee as mentioned above shall be payable through demand draft or pay order in the name of Director General Peshawar Development Authority (Non refundable).
4. The tender documents must be signed by an authorized the firm company.
5. The contractors/bidders who quote their bids/rates more than 10% below the Engineer's estimate shall submit an additional security in the form of call deposit equal to 8% of the estimated cost. After commencement of work by the successful bidder 8% call deposit should replaced with a bank guarantee of the same amount from the scheduled bank in accordance with the notification KPPRA M&E Estt: 1-5 2016, dated 24.05.2016 as

6. The Firms/companies must have sufficient experience in similar nature of works supported by documented evidence.
7. Sealed bids shall be sent through registered mail/courier service which must reached in the office of the undersigned before closing time and date mentioned above.
8. The bid documents received through fax will not be acceptable.
9. The bidders are at liberty to seek any clarification or further information from the office of the undersigned if desires.
10. Only upto two decimal digits (0.00) will be considered for evaluation of the quoted bid. If any documents submitted along with bid documents found false/bogus the registration of the contractor/firm shall stands cancelled/blacklisted. Conditional/incomplete bids shall not be acceptable.
11. Tender shall be opened in the office of the undersigned.
12. In case bid becomes tie, it shall be retendered.
13. All Federal and Provincial duties/stamp duty/taxes including sales tax will be recoverable as per directives of the Government issued time to time.
