
## (NOTICE INVITING E-TENDER)

### TERMS & CONDITIONS

1. 2% Earnest Money of estimated cost must accompany with the tender forms which can be downloaded from PDA website ([www.pda.gkp.pk](http://www.pda.gkp.pk)) (upto one day prior to the bid opening date) in the shape of "Call Deposit" in the name of Director General PDA. Furthermore, photocopies of the requisite documents like income tax Certificate, PEC registration etc. must be attached with the tender form. Original must be produced for confirmation.
2. Tender form/documents fee to be submitted separately in shape of call deposit/pay order in the name of Director General, PDA
3. Incomplete / disfiguring / overwriting / by hand/ delayed bids shall be considered non-responsive.
4. All Federal and Provincial duties/ taxes including sales tax will be recoverable as per directives of Government issued from time to time.
5. In case the bid becomes tie, the work will be retendered.
6. Rates must be written both in figures and words. The contractor will sign all the pages of BOQ. In case of Non-compliance, tender shall not be entertained for competition.
7. Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2017/prevailing market rates with the approval of the competent authority.
8. The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals. The procuring entity shall upon request communicate to any contractor who submitted a bid or proposal the grounds for rejection or of all bids or proposals as per KPPRA 47(1).
9. The contractors/bidders who quoted their bids/rates more than 10% below the Engineer's Estimate shall submit an Additional Security in the form of call deposit equal to 8% of the estimated cost. After commencement of work by the successful bidder 8% call deposit should replace with a bank guarantee of the same amount from the scheduled bank in accordance with the notification KPPRA/M&E/Estt:/1-5/2016 Dated 24/5/2016.
