TERMS AND CONDITIONS.

1. Sealed bids indicating monthly rent of the space along with Rs: 200,000/- (two lacs) security in shape of call deposit in the name of Director General, PDA for each space/site to reach this office on or before 18.04.2018 by 1400 hours. The bids will be opened on the same day at 1430 hours in the presence of the bidders or their authorized representatives who may prefer to be present. No bids shall be accepted after 1400 hours.
2. The security amount of Rs: 200,000/- will be adjusted towards last months (s) rent of the space/site.
3. Monthly rent of the Tower shall be paid in advance on yearly basis.
4. That the rent shall increase @ 10% per year.
5. That the space/site shall be rented out for a period of 6 years (72 months).
6. That the Authority will have the right to cancel the permission prior to renewal of the agreement at any time and the Company will have no right to litigate.
7. A rent agreement will have to be executed with PDA prior to handing over possession of site.
8. That the site shall not be used for the purpose other than installation of BTS Tower.
9. That the Company will pay all Taxes levied by the Federal/Provincial Government.
10. That the Company shall, at its own expenses and risk, construct and finalize the design of its Antenna Tower structure to be installed in the premises.
11. That the Company will be bound to obtain and provide NOC from EPA.
12. Detailed terms and conditions of the auction can be seen in office of the undersigned on any working day.
13. In case of sharing with other mobile companies, NOC from PDA will be obtained and equal rent to PDA will also be deposited. The time period of agreement/NOC of the sharing Company shall not exceed the expiry time of the main agreement carried out with the hosting Company.
14. The Bidding Committee/Competent Authority reserves the right to reject any or all bids by giving cogent reason thereof.
